This has reference to your proposal IA/CG/IND/237214/2021 dated 13.10.2023 along with the application in prescribed format - Form 3 (CAF, Form – I Part A & B) and revised PFR and sought for amendment in Standard Terms of Reference accorded by the Ministry vide File No. J-11011/780/2008-IA.II (I) dated 06.11.2021 w.r.t. downsizing the proposed project which includes reducing the capacities and changing the configuration of some proposed facilities, dropping Ferro Alloy plant, brick manufacturing unit, slag crushing unit and briquetting unit, reduction in the project area from 38.98 ha to 26.7 ha along with other changes in basic parameters.

#### **Details submitted by Project proponent**

- 4. M/s. Satya Power & Ispat Limited had initially applied for Terms of Reference vide Proposal No. IA/CG/IND/237214/2021 dated 03.11.2021 for Proposed expansion of Steel Plant DRI Kilns (Sponge Iron from 90,000 TPA to 4,86,000 TPA), New Induction Furnace with matching LRF & CCM (Billets / Ingots / Hot Billets) 2,97,000 TPA, New Rolling Mill (TMT Bars / Structural Steel) 2,64,000 TPA, New Ferro Alloys Unit 2 x 9 MVA (FeMn 50,400 TPA / SiMn 28,800 TPA / FeCr 30,000 TPA / FeSi 14,000 TPA), New WHRB based Power Plant 34 MW & New FBC based Power Plant 30 MW, New Brick manufacturing unit 50,000 bricks/day, New Slag crushing unit 100 TPD, New Briquetting unit 200 Kg/hour at Gatori & Sendri Villages, Bilha Tehsil, Bilaspur District, Chhattisgarh. Accordingly, Standard ToR was granted by the Ministry vide File No. J-11011/780/2008-IA.II (I) dated 06.11.2021.
- 5. The instant proposal is for seeking amendment in Terms of Reference accorded by the Ministry vide F. No. J-11011/780/2008-IA.II (I) dated 06.11.2021 w.r.t. downsizing the proposed project which includes reducing the capacities and changing the configuration of some proposed facilities, dropping Ferro Alloy plant, brick manufacturing unit, slag crushing unit and briquetting unit, reduction in the project area from 38.98 ha to 26.7 ha along with other changes in basic parameters. The details are at **Annexure-I.**
- 6. Justifications for Amendment: Post public hearing conducted on 7th July, 2022, the final EIA was submitted in PARIVESH portal vide proposal No. IA/CG/IND1/418285/2023 on 14th February, 2023. The proposal was considered in 25th EAC meeting (Industry-I) held on 23rd March, 2023 after detailed deliberations, the committee recommended to defer the proposal and the EAC made an opinion that the complete land shall be acquired by the project proponent. As per granted ToR, the total project area for the expansion project was 38.98 Hectares. But due to some reasons some part of additional land area is not purchased by the company. At present, 26.7 Ha of land is under the possession of the company. So, the company management has decided to modify the expansion proposal in the existing acquired 26.7 Ha land area.
- 7. It is reported that there is no violation under EIA, 2006/court case/show cause/direction related to the project under consideration.

#### **Deliberation by the Committee**

- 8. The EAC noted the following
- i. M/s. Satya Power & Ispat Limited had initially applied for Terms of Reference vide Proposal No. IA/CG/IND/237214/2021 dated 03.11.2021 for Proposed expansion of Steel Plant DRI Kilns (Sponge Iron from 90,000 TPA to 4,86,000 TPA), New Induction Furnace with matching LRF & CCM (Billets / Ingots / Hot Billets) 2,97,000 TPA, New Rolling Mill (TMT Bars / Structural Steel) 2,64,000 TPA, New Ferro Alloys Unit 2 x 9 MVA (FeMn 50,400 TPA / SiMn 28,800 TPA / FeCr 30,000 TPA / FeSi 14,000 TPA), New WHRB based Power Plant 34 MW & New FBC based Power Plant 30 MW, New Brick manufacturing unit 50,000 bricks/day, New Slag crushing unit 100 TPD, New

Briquetting unit - 200 Kg/hour at Gatori & Sendri Villages, Bilha Tehsil, Bilaspur District, Chhattisgarh. Accordingly, Standard ToR was granted by the Ministry vide File No. J-11011/780/2008-IA.II (I) dated 06.11.2021.

- ii. The instant proposal is for seeking amendment in Terms of Reference accorded by the Ministry vide File No. J-11011/780/2008-IA.II (I) dated 06.11.2021 w.r.t. downsizing the proposed project which includes reducing the capacities and changing the configuration of some proposed facilities, dropping Ferro Alloy plant, brick manufacturing unit, slag crushing unit and briquetting unit, reduction in the project area from 38.98 ha to 26.7 ha along with other changes in basic parameters as detailed in **Annexure-I**.
- iii. The PP has reported that Post public hearing conducted on 7th July, 2022, the final EIA was submitted in PARIVESH portal vide proposal No. IA/CG/IND1/418285/2023 on 14th February, 2023. The proposal was considered in 25th EAC meeting (Industry-I) held on 23rd March, 2023 after detailed deliberations, the committee recommended to defer the proposal and the EAC made an opinion that the complete land shall be acquired by the project proponent. As per granted ToR, the total project area for the expansion project was 38.98 Hectares. But due to some reasons some part of additional land area is not purchased by the company. At present, 26.7 Ha of land is under the possession of the company. So, the company management has decided to modify the expansion proposal in the existing acquired 26.7 Ha land area.
- iv. PP has also reported that as per MOEF&CC guideline, Public Hearing was conducted on 7th July, 2022, the final EIA was submitted in PARIVESH portal on 14th February, 2023. The EAC deliberated that since this is a case of downsizing the proposed project, therefore, the public hearing holds valid after the proposed amendment.

#### **Recommendations of the Committee**

9. After deliberations, the Committee recommended the proposal for amendment in ToR granted vide F. No. J-11011/780/2008-IA.II (I) dated 06.11.2021 as detailed in Annexure-1. The other terms and conditions of ToR dated 06.11.2021 shall remain the same.

#### **Decision of MoEF&CC**

- 10. The Ministry of Environment, Forest and Climate Change (MoEF&CC) has considered the aforesaid proposal based on the recommendations of the Expert Appraisal Committee (Industry 1) and hereby decided to grant amendment in the ToR dated 6th November, 2021.
- 11. All other terms and conditions mentioned in the earlier TOR letter No. J-11011/780/2008-IA.II (I) dated 06.11.2021 shall remain unchanged.
- 12. The PP shall obtain fresh Terms of Reference in case of change in scope of the project if any.
- 13. This issues with the approval of the Competent Authority.
